AMENDMENTS TO THE REGULATION OF THE RESIDENCE PERMIT FOR INVESTMENT (“GOLDEN VISA”)

On the past 12th of February of 2021, Decree-Law 14/2021, which alters the legal framework concerning the entry, permanence, exit and removal of foreigners into and out of Portuguese national territory, namely the legal framework of the residence permit for investment (widely known as Golden Visa), was promulgated

What will change?

With the enforcement of the new amendments, investments that bestow the right to a Golden Visa will be restricted through the increase of its minimum value or the reduction of the geographical area where they are to be effected. The main restrictions are the following:

- a) The value of investment through capital transfer increases from 1 million euros to 1,5 million euros;
- b) The value of investment through acquisition of units of investment funds or venture capital funds dedicated to the capitalisation of corporations increases from €350.000,00 to €500.000,00;
- c) The investment in **residential** real estate is only relevant to access a Golden Visa if conducted in the regions of Madeira and Azores or in the inland areas.

We present a list of the inland areas in which real estate investment continues eligible to attain a Golden Visa attached to this newsletter.

What remains unaltered?

Foreign investors will continue to access the Golden Visa through investment in real estate located in coastline areas (namely Lisbon, Porto, and Algarve) if it is not intended for **residential** purposes.

The minimum value of investment in real estate is equally unchanged, that is, the amount of €500.000,00 or of €350.000,00 (for the acquisition of real estate built at least 30 years ago or located in areas of urban rehabilitation along with the undergoing of

rehabilitation construction work).

When does it come into force?

The amendments come into force on the 1st of January of 2022 and are only applicable to the Golden Visa applications effected from that date.
